
Development of the NGO sphere in Belarus until 2020

- There are quite a lot of NGOs registered in Belarus
- But the fact of registration does not mean the actual functioning
- And the fact of work does not really mean the impact on society and interaction with people
- The development of the NGO sphere in Belarus is based on complex intertwined direct and indirect factors: from the dynamics of the national economy to foreign policy factors
- Year 2020 is an important milestone for NGO in Belarus

2022 : The scope of public organizations according to the Ministry of Justice

- 15 political parties
- 25 trade unions
- 2978 public associations (226 international, 785 republican and 1967 local)
- 45 unions (associations) of public associations
- 227 foundations
- 7 republican state public associations



NGOs in 2020


- peculiarity of the socio-economic development of Belarus in 2020 was the simultaneous action of several unfavorable factors for the state at once: COVID, economic shocks and the growth of politicization
- public organizations, for the most part, were not direct participants in political activity
- activities of NGOs in Belarus contributed to the formation of stable horizontal ties
- NGOs in Belarus until 2020 have played an important role in reducing paternalism in the Belarusian society


NGO sphere after August 2020

NGO sphere after August 2020

- mass liquidation of public associations (366 non-profit organizations in Belarus are in the process of forced liquidation)
- A significant number of active participants and leaders of public associations were imprisoned
- NGO employees and activists have gone abroad
- new format of work (work with the diaspora, work from geographically dispersed offices, strengthening the role of IT solutions in work, partial work within the country)

Conclusions

- The state of the sphere of public organizations in Belarus after 2020 should be characterized as a crisis
- the sphere of public organizations in Belarus is undergoing a qualitative shift - NGO sphere is transforming in the new conditions
- the problem of losing connection with Belarus and its current agenda
- improving the conditions for the activities of public organizations in Belarus will depend entirely on the development of the socio-economic and political crisis
